

JOINT RESOLUTION

WHEREAS, THE CITY OF MOULTON BY CITY ORDINANCE NO. _____, AND LAVACA COUNTY BY COMMISSIONERS COURT ORDER DATED July 10, 1997, HAVE ESTABLISHED SIMILAR PROGRAMS OF COMPREHENSIVE EMERGENCY MANAGEMENT WHICH INCLUDE THE MITIGATION, PREPAREDNESS RESPONSE AND RECOVERY PHASE OF EMERGENCY MANAGEMENT; AND

WHEREAS, THE CITY AND COUNTY FIND THAT VULNERABILITY TO MANY POTENTIAL HAZARDS IS SHARED BY RESIDENTS OF MOULTON AND THE UNINCORPORATED PORTIONS OF LAVACA COUNTY; AND


WHEREAS, THE CITY AND COUNTY FURTHER FINDS THAT THE COMMON GOAL OF EMERGENCY MANAGEMENT CAN BE BEST ACHIEVED THROUGH AN ORGANIZATION WHICH SHARES THE COMBINED RESOURCES OF THE CITY AND COUNTY; AND


WHEREAS, THE CONTEMPLATED ACTION IS SPECIFICALLY AUTHORIZED BY THE AFOREMENTIONED ORDINANCE AND COURT ORDER;

THEREFORE, BE IT RESOLVED THAT THERE IS HEREBY ESTABLISHED THE LAVACA COUNTY EMERGENCY MANAGEMENT ORGANIZATION WHICH SHALL CONSIST OF THE OFFICERS AND EMPLOYEES OF THE CITY AND OF THE COUNTY AS DESIGNATED IN A JOINT EMERGENCY MANAGEMENT PLAN, TOGETHER WITH SUCH ORGANIZED VOLUNTEER GROUPS AS THE PLAN MAY SPECIFY; AND


BE IT FURTHER RESOLVED THAT THE MAYOR OF MOULTON AND THE LAVACA COUNTY JUDGE SHALL MUTUALLY AGREE THAT THE EMERGENCY MANAGEMENT COORDINATOR WILL COORDINATE ALL ASPECTS OF THE MOULTON/LAVACA COUNTY PROGRAM OF COMPREHENSIVE EMERGENCY MANAGEMENT, INCLUDING THE PREPARATION AND MAINTENANCE OF A JOINT EMERGENCY MANAGEMENT PLAN FOR MOULTON AND LAVACA COUNTY IN ACCORDANCE WITH THIS RESOLUTION.


