Below is the Lavaca County Sheriff's office fee chart based on the **Texas Public Information Act (TPIA)** guidelines set by the **Texas Attorney General.** These guidelines ensure consistency, fairness, and legality when charging for public records.

Additional Notes:

- Minimum cost of \$1.00 for copies. If more than 10 pages, standard charges will be assessed.
- If the total cost is estimated to exceed \$40.00, the requestor will be provided with an **itemized written estimate** before work begins.
- Lavaca County Sheriff's Office may require a deposit if costs exceed \$100.00 or if the requestor has a history of nonpayment.
- Payment for Request: **Money Order or Cashier Check ONLY**, payable to Lavaca County Sheriff's Office.
- Must provide a valid State issued Driver's License or Identification Card with any request.
- Request MUST be written request are only accepted in one of the following forms: **In Person:** at Lavaca County Sheriff's Office 38 FM 318, Hallettsville, TX 77964
