## RESOLUTION OF SUPPORT FOR A REGIONAL PUBLIC DEFENDER'S OFFICE

WHEREAS, the Sixth Amendment to the United States Constitution guarantees the right to counsel for all persons accused of a crime, regardless of their ability to pay for legal representation; and

WHEREAS, quality indigent defense is essential to upholding the principles of fairness, justice, and the rule of law; and

WHEREAS, across Texas and the nation, criminal courts are experiencing increased caseloads for an ever-decreasing number of attorneys who are available to represent indigent criminal defendants; and

WHEREAS, Victoria County has been working with the Texas Indigent Defense Commission and intends to apply for an improvement grant to fund a Regional Public Defender's Office; and

WHEREAS, the implementation of this program will positively impact Lavaca County by providing necessary indigent defense support; and

WHEREAS, to be eligible for funding, all judges of the statutory county/district courts hearing criminal matters punishable by incarceration or juvenile matters in the county must sign a cooperation agreement in support of the program;
