1. Executive Session to discuss pending litigation with attorney representing Lavaca County. (County Judge)

2. Presentation of retirement plaque to Patty Grahmann for 24 years and 1 month of dedicated service to Lavaca County. (County Judge)

The Commissioners' Court Assistant will then E-mail one free copy of that permit to the permittee and to the Sheriff's office. Any and all future copies of said permit will only be available at the County Clerk's office for the standard fees. That will give an opportunity for those folks that paid their permits to get their one free copy and will be done in the most timely manner possible, next to immediately. It will allow for future copies to be obtained through the Clerk's office with the legal fee required.
