

Greg Wine, P.E., LEED AP and Guillermo I. Salcedo, P.E., CFM with Huitt-Zollars, Inc, spoke on this agenda item and answered questions. Many questions could not be answered and were directed to the Grant Administrator who was absent from the meeting at this time. It was announced that another meeting would be held so that the Grant Administrator could be present for further discussion.

"Your Honor, I make a motion to split the LMI portion between Precinct 1 and Precinct 3, the remainder of the grant be split by Precinct 2 and Precinct 4."

Judge expanded on the motion stating: "Motion made by Precinct 1, seconded by Precinct 3 to split the LMI portion of the allocated grant of 2,710,000.00 evenly with the remainder of the grant going to an even split between Precincts 2 and 4. A Net Value of evenly split Grant between the 4 Precincts."
