\*\*At the request of the Lavaca County Auditor, Shana R. Opela, and Commissioner Pct. #4, Dennis Kocian, the memo provided by Shana Opela is to be made part of the record for the Commissioners' Meeting as read:

"The IRS defines a "public safety officer" as an "individual serving a public agency in an official capacity, with or without compensation, as a law enforcement officer, a firefighter, a chaplain, or as a member of a rescue squad or ambulance crew" FR(IRS) §1.274-5. The facts and circumstances of a particular situation, not merely a job title, determine whether an individual is a public safety officer. The determination is made based on the facts and circumstances of the individual's employment, including their training, legal authority, and legal responsibility.

There are risks with allowing the EMC to utilize a county vehicle and allowing the EMC to take home on a daily basis. In the event of an IRS audit there could be a determination that the emergency management position is not considered a "public safety officer" in which the use of the vehicle would be taxable to the EMC. In this circumstance, the IRS will prevail, not Lavaca County.

My recommendation is to allow the EMC to drive the vehicle to Precinct 3 and park at the county barn on a daily basis. If the need to utilize the vehicle after normal business hours arises, the vehicle will be slightly more than a mile from the employee's residence."
