6. EMS Update. (EMS Director)

NO DOCUMENTATION SUBMITTED TO THE MINUTES OF THE COURT.

Michael Furrh, EMS Director, thanked the EMS employees, County employees, and City Workers for the hard work due to the icy weather the week of February 15th to the 18th. An extra ambulance was staffed at this time. EMS Supervisors met dealing with the issues from the weather of no power and no water. Recognized Egon Barthels, Emergency Management Officer, for his dedication the past week. Will be talking with Colorado County in the next week on the vaccination plan for distribution.

7. Emergency Management Update. (OEM)

NO DOCUMENTATION SUBMITTED TO THE MINUTES OF THE COURT.

Egon Barthels, Emergency Management, thanked the County Commissioners, Tx DOT, Sheriff's Office, and Mr. Steffek from Pepsi Bottling Company of Hallettsville.

Due to the Sheriff's Office receiving welfare calls due to the lack of electricity, the Knights of Columbus Council #2433 allowed the use of their facility for a warming center. Pepsi Bottling Company donated 25 cases of water towards the KC Hall warming center. The leftover water was donated to the Lavaca County EMS and Yoakum Fire-EMS.

Egon Barthels spoke of the response to accidents with traffic control, being in contact with all the Electric Co-Operatives that serve the county, boil notifications of water for Moulton, Shiner and Yoakum, Pepsi Bottling Company's donation of 75 to 80 cases of water for citizens of Moulton, Home Land Security distribution of water, help unloading of and storing of MRE's from Precinct #3 and Lavaca County EMS. Distributions of the MRE's and of water to the cities with boil notifications and or future events. Egon also spoke of TDEM's survey of taking pictures of damage to get an assessment of what has taken place, and the Disaster Declaration issued by President Biden, received by Texas Governor Abbott for Lavaca County and 76 other counties for individual and public assistance through FEMA and the opening of bars and restaurants to 75%.


